In supersession of the previous notifications issued in this behalf vide No.11/123/99-PE(4)/2315 dated 7.2.2008, 11/123/99-IPF(4)/2371 dated 7.2.2008 and in pursuance of the decision taken by the Council of Ministers in their meeting dated 7.3.2018, the Governor of Punjab is pleased to revise the fees for the various services rendered by the Department of Chief Electrical Inspector under The Electricity Act, 2003 and the Regulations made thereunder as per the schedule below:-

Schedule

A. For testing and inspection of New Electrical installations installed in a generating or receiving station or in any other place in which energy is generated, transferred, distributed or used at a pressure not less than 100 Volts/comprising the following categories, namely:-

1.	<u>Installations upto 33 KV:-</u>	Fee (in Rupees)
	(i) Upto 100 KVA	One thousand
	(ii) Exceeding 100 KVA, but not exceeding 1000 KVA.	Four thousand
	(iii) Exceeding 1000 KVA	Four thousand plus Rupees one hundred for every additional 100 KVA and a part thereof.

2.	<u>Extra High Voltage Installations:-</u>	
	(i) Upto 5000 KVA	Four thousand

3.	<u>Equipment installed separately:-</u>	Eight hundred.

1.	<u>Installations of lines upto 33 KV:-</u>	
	(i) For a line upto length of one km.	Four hundred
	(ii) For every additional length of one Kilometre of the line or a part thereof.	Fifty
	(iii) For any alteration or replacement in an installation without increasing its capacity.	Four hundred
	(iv) For any alteration or replacement of line exceeding 33 KV without increasing its capacity.	One thousand

	(v) Upto 1000 H.P.	Four thousand upto first five installations and Rupees fifty for every additional installation.
	(vi) Exceeding 1000 H.P.	Four thousand upto first five installations and Rupees fifty for every additional installation.


Note:- (i) For calculation of fee of these installations the capacity where it is given in KVA, one KVA shall be deemed to be equivalent to one H.P for the purpose of levy of fees.

(2) The same fee shall be charged for each installation for any subsequent inspection for the installations specified under categories A, B, C and D above.

(3) The terms "KVA", "KV" and "HP" used in this notification stand for kilo volt Ampere, Kilo Volt and Horse Power respectively.



In pursuance of the decision taken by the Council of Ministers in their meeting dated 7.3.2018 and the provision of Regulation 29 of the Central Electricity Authority (measures relating to Safety and Electric Supply) Regulations, 2010 and all other powers enabling him in this behalf, the Governor of Punjab is pleased to make the following further amendment in Government of Punjab, Department of Power Notification No.2/73/90/IPE(I)/13842 dated 31.7.1991 namely:-

AMENDMENT

In the said notification:

1. In Clause 7, in sub-clause (c), in item (ii), for the words "eighty rupees" the words "seven hundred and fifty rupees" shall be substituted.
2. In Clause 20 for the words, "fifty rupees" the words "two hundred rupees" shall be substituted.

5. In clause 28, for the words, "eighty rupees and forty rupees" the words, "two hundred rupees and two hundred rupees" shall be substituted.
6. For clause 30, the following clause shall be substituted, namely:-
Fees:- The fee on the scales prescribed below shall be charged for issuing Certificate of Competency to Supervisors and licenses to Electrical Contractors:-

The Treasury receipt in original shall be forwarded to the Secretary, Licensing Board-cum-Chief Electrical Inspector of Government of Punjab alongwith the application;

(2) The renewal of Electrical Contractors license or Certificate of Competency or Wireman Permit shall be made for the period opted by the Electrical Contractor or Certificate holder or permit holder as the case may be. The option once exercised shall be final.
